- c. No TA/DA shall be admissible for appearing in the skill test/signage and interview.
- d. Candidates who are already in Government Service (Central / State or PSU) may apply through proper channel. They shall have to produce "No Objection Certificate" from the present employer at the time of document verification and they will have to submit release order at the time of joining.
